

Dance Floor Rental

Rent our portable dance floor for your next Wedding, Team Building, Life Celebration, Vow Renewal, Quinceanera, Corporate Party, Birthday Party, Family Reunion, Group Class/Event, Friend Party/Get Together, Anniversary, Line Dancing, Picnic, Church Event, Performance... and the list goes on! *The floor is suitable for MOST indoor or outdoor events. The floor is best on flat surfaces, such as carpet, linoleum/tile, cement, and wood (to protect your own floors at an event).*

Base Rental, includes the following:

\$650.00

- 400 sq ft dance floor (*configurations for your space up to 400 sq ft*)
- Free delivery (*within 20 miles of DWTDS address in Bend, OR*)
- Free set-up and takedown
- Delivery and pickup between 10:00 AM and 8:00 PM (*for events outside this schedule, see "Add-Ons"*)
- *Add-on options: mileage, additional rental time, 45 min group class, 90 min group class. (see below)*

Add-ons:

- **Extra mileage:** 21+ miles from DWTDS address (*62880 Peerless Court in Bend, OR. Includes; Sunriver, Madras, Prineville and areas in between*) **\$50.00 for same day delivery/pickup.**
- **Extra Floor Rental Time:** **\$200 for next-day pickup**
(for events running later than 8:00 PM)
\$250 for next-day pick up AND
21+miles from DWTDS.
- **Group Classes, as follows:**
 - **45 min Classes:**
 - Up to 30 people \$250.00
 - 31-50 people \$350.00
 - **90 min Classes:**
 - Up to 30 people \$460.00
 - 31-50 people \$630.00

Financial Investment:

Once you've requested an event date, you will be sent an email invoice confirming availability and requesting payment. At this time, a **non-refundable deposit of \$200 must be paid within 5 days to hold the date** for your event. **The balance of your rental cost will be due no later than 1 month prior to your event date.** Once you've paid the balance of rental, **it becomes non-refundable.** **A \$500 refundable cash deposit will be due at the time the floor is scheduled to be dropped off-** prior to set up. This deposit will be returned after floor pick up, provided there is no damage to the floor. (**Once the floor is set up, DWTDS rep and client will look over the floor and sign a "pre-event floor condition" release.*)

Note: Should the initial deposit invoice not be paid within 5 days, DWTDS will assume you no longer need the floor for your event and your date will no longer be held.



The basic rule of thumb to keep in mind when considering dance floor size is that usually about 50% of your guests will dance at any given time. However, you know your guests best—consider what type of crowd will be attending and decide whether they're the type to dance the night away or if they're more likely to enjoy lively conversations while seated.
